

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to pay the sum of \$1,623,390.00 in settlement of the complaint against The City of San Diego, its agents and employees (Superior Court Case No. 484152, Patrick Duggan v. Gordon Lee George, et al.), resulting from the personal injuries and property damage alleged to have been sustained by Patrick Duggan on or about November 7, 1981; and any and all alleged losses sustained by Patrick Duggan as a result of said incident;

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one warrant check in the amount of \$1,023,390.00 to the Life Insurance Company of North America for the purchase of an annuity for Patrick Duggan and one warrant check in the amount of \$600,000.00 to Patrick Duggan and his attorney of record James R. Milliken, in full and final settlement of all claims and complaints.
