California corporation, all of the City's right title and
interest in the drainage and sewer easements in a portion of
Parcel 2 of Parcel Map No. 12734; and quitclaiming to THE
SECOND CARROLL RIDGE GROUP, a general partnership, all of the
City's right title and interest in the drainage and sewer
easements in a portion of Lots 15 and 16 of Carroll Ridge
Business Park IV, Map No. 10749, all of which are more
particularly described in said deeds.

2. That the City Clerk of said City shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
