WHEREAS, in approving the final map of Resubdivision of Nobel Terrace Unit No. 7, the City shall receive easement interests which will allow the quitclaim of existing drainage easements within the area of the subdivision; and

WHEREAS, the City Manager has certified that the easement interests to be exchanged are approximately equal in value; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. RR- 260095-1, quitclaiming to DOUGLAS ALLRED DEVELOPMENT COMPANY, a California corporation, all of the City's right, title and interest in the drainage easements, as more particularly described in the quitclaim deed.

2. That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
