

RESOLUTION NUMBER R-260102

Adopted on February 13, 1984

WHEREAS, San Diego is one of the largest metropolitan areas in the state and is a major center of business and commerce; and

WHEREAS, San Diego is the second most populous city in the state and will become the second most populous county in the state in 1985; and

WHEREAS, San Diego is the home of one of nine campuses of the University of California; and

WHEREAS, the economic and commercial development of San Diego has been greatly benefitted by the University's presence in our community; and

WHEREAS, San Diego's future is closely linked to its institutions of higher education; and

WHEREAS, only one San Diegan has ever served on the University of California Board of Regents in the 120-year history of the University; and

WHEREAS, no San Diegan is currently serving on the Board of Regents; and

WHEREAS, the terms of two members of the University of California Board of Regents will expire in May of 1984; and

WHEREAS, there are many San Diegans who have the experience, the qualifications, and the dedication to serve ably the needs of the entire state; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
that the Governor of the State of California be and he is hereby
urged to appoint San Diegans to the University of California
Board of Regents in 1984.
