

RESOLUTION NUMBER R- 260103

Adopted on FEB 13 1984

WHEREAS, approximately five million gallons per day of sewage from Tijuana is flowing uncontrolled into San Diego; and

WHEREAS, this uncontrolled flow of sewage is a threat to the health and welfare of San Diego residents; and

WHEREAS, the full nature and extent of the health hazard to San Diego residents must be better understood in order for appropriate action to be taken; and

WHEREAS, insufficient surface and underground water testing has been carried out to identify the full range of hazards to which San Diego residents are being exposed; and

WHEREAS, The City of San Diego is responsible for the health, safety and welfare of all its residents; and

WHEREAS, The City of San Diego has contracted with the County Public Health Officer to protect the health of City residents; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager is hereby directed to contact appropriate Federal, State and local officials to carry out tests necessary to identify all hazards from uncontrolled flow of sewage into San Diego from Tijuana.

2. That the City Manager is directed to report back in two (2) weeks with a comprehensive program to accomplish the necessary testing required.
