
Adopted on FEB 21 1984

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those public street and general utilities and access easement deeds of NEAL H. HOOBERMAN and MICHAEL KENNEY, executed in favor of The City of San Diego, bearing date of December 27, 1983, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 260130-1 and RR- 260130-2, granting to said City easements for public streets, general utilities and water access in a portion of the Southeast Quarter of Section 1, Township 15 South, Range 3 West, S.B.M., as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public streets is hereby dedicated as and for public streets, and the same are hereby named MIRAMAR ROAD and ARJONS ROAD.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
