## RESOLUTION NUMBER R- 260131

WHEREAS, the California Ballet Company scheduled a special performance for senior citizens of "The Nutcracker" on December 20, 1983; and

WHEREAS, said special performance was scheduled at the behest of The City of San Diego's Senior Services Division, with assurance of a sell-out being given; and

WHEREAS, despite large discounted prices on tickets offered for the special performance, only 300 tickets were sold, assuring the financial infeasibility of performing said show; and

WHEREAS, as a result of the extremely poor ticket sales, the special performance had to be cancelled; and

WHEREAS, the Ballet Company was obligated to pay a rehearsal fee of \$750 for December 19th and a rental fee of \$1,150 for December 20th, the day scheduled for the show; and

WHEREAS, the show was cancelled twenty days prior to the scheduled date and no events were competing for that time; and

WHEREAS, for the financial well-being of the California Ballet Company, an outstanding cultural resource, plus the reasons of financial infeasibility stated above, it is deemed desirable to waive the fees due from the California Ballet Company; and

WHEREAS, Council Policy 700-43, section A.3. requires that all fees and charges be paid, even if waived by Council, and that payment shall be made to the Convention and Performing Arts Center (herein called "Center") from a funding source specified by Council; and

WHEREAS, in the interest of equity and cultural preservation, it is recommended that the waived fees be paid out of General Fund Unallocated Reserve funds; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the fees and charges in the amount of \$1,900 owed by the California Ballet Company to the Convention and Performing Arts Center for scheduled but unused Center facilities be and the same are hereby waived, pursuant to the provisions of Council Policy 700-43.

BE IT FURTHER RESOLVED, that pursuant to Council Policy 700-43, section A.3., the Auditor and Comptroller be and he is hereby authorized to transfer and expend the sum of \$1,900 from the General Fund (100) Unallocated Reserve (605) to the Convention and Performing Acts Center as payment in full for the facilities charges associated with the cancelled special performance of "The Nutcracker" by the California Ballet Company.
