RESOLUTION NUMBER R- 260132

WHEREAS, Section 64.0518 of the San Diego Municipal Code provides that a Trucker's Discharge Permit fee may be established by resolution of the City Council upon the giving of ten (10) days' notice of intention to establish, amend, or increase said fee; and

WHEREAS, said notice has been given by posting the intention to establish said fee by the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to Section 64.0518 of the San Diego Municipal Code, the following Trucker's Discharge Permit fees are established to cover the expense of permitting, monitoring, treating and disposing of trucked domestic and industrial wastes:

- (1) The annual permit fee for the discharge of septic tank, chemical toilet and other domestic wastes into the San Diego Metropolitan Sewage System shall be \$25.00 plus \$5.00 for each 1000 gallons of wastes to be discharged.

(2) The permit fee for the discharge of Industrial Wastes into the San Diego Metropolitan Sewerage System shall be \$25.00 plus \$10.00 for each 1000 gallons of wastes to be discharged.

BE IT FURTHER RESOLVED, that the fees established by this resolution shall become effective on March 1, 1984.
