WHEREAS, the construction of the San Ysidro Branch Library Expansion is near completion, and

WHEREAS, the expanding library facilities require initial furnishings and equipment to establish the library as a going concern, and

WHEREAS, by Resolution No. 256059 adopted on March 22, 1982, the Council of the City of San Diego authorized the expenditure of \$28,000 for initial furniture and equipment for the San Ysidro Branch Library Expansion from Capital Outlay Fund CIP No. 35-053, and

WHEREAS, the \$28,000 previously authorized is insufficient to cover the costs of purchasing initial furniture and equipment for this library facility, and

WHEREAS, it is estimated that \$22,000 additional funds will be necessary to purchase the initial furniture and equipment for the San Ysidro Library facility to establish it as a going concern,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of San Diego that the expenditure of \$22,000 from Capital Outlay Fund 30245, CIP No. 35-053 (San Ysidro Branch Library) be hereby authorized, solely and exclusively, for the purchase of initial furnishings and equipment.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the necessary initial FURNISHINGS AND EQUIPMENT FOR THE SAN YSIDRO BRANCH LIBRARY EXPANSION.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for initial FURNISHINGS AND EQUIPMENT FOR THE SAN YSIDRO BRANCH LIBRARY EXPANSION.
