

RESOLUTION NUMBER R- 260138

Adopted on FEB 21 1984

WHEREAS, the Council on June 10, 1983 authorized construction of the Sorrento Valley Bikeway; and

WHEREAS, the Sorrento Valley Bikeway will serve the University of California at San Diego Campus and Torrey Pines State Park with the improved bicycle access; and

WHEREAS, providing bicycle lanes on North Torrey Pines Road will require the removal of current parking places; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That there is hereby established on both sides of North Torrey Pines Road from Genesee Avenue northerly to the City limits a Class II Bike Route.

2. That parking of vehicles on both sides of North Torrey Pines Road northerly from Genesee Avenue to the City limits be and it is hereby prohibited.

3. That the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
