That the acceptance by the City Manager of that street easement deed of PARDEE CONSTRUCTION COMPANY, a California corporation, executed in favor of The City of San Diego, bearing date of July 25, 1983, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- **260149**, granting to said City an easement for public street purposes in a portion of Sections 16 and 21, Township 14 South, Range 2 West, San Bernardino Meridian, and a portion of Rancho de los Penasquitos, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SABRE SPRINGS PARKWAY.
