

RESOLUTION NUMBER R-260150

Adopted on February 21, 1984

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, and RANCHO CARMEL, a general partnership, executed in favor of The City of San Diego, bearing date of July 25, 1983, copies of which deeds are on file in the Office of the City Clerk as Documents Nos. RR-260150-1 and RR-260150-2, granting to said City right-of-way for a freeway interchange on Interstate 15 at the proposed intersection with State Route 56, in a portion of Rancho de los Penasquitos, as more particularly described in said deeds, be, and the same is hereby approved.

That the City Manager is authorized to accept the deeds for the property needed for a new interchange with I-15, and to transfer said property to the State of California.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
