WHEREAS, the matter of providing support staff to the Reinvestment Task Force was discussed in City Manager Report No. 83-501, dated December 1, 1983; and

WHEREAS, it was recommended by the City Manager that said support staff position be assigned to and located under the Housing Commission; and

WHEREAS, the source of funding for said position for the remainder of fiscal year 1984 would be the 1984 CDBG contingency reserve; and

WHEREAS, the matter and issue was discussed by the Rules Committee on December 7, 1983 and the authorization for the additional support position and funds related thereto was unanimously approved by the Committee; and

WHEREAS, it is now necessary and required that said funds be transferred to accommodate said proposal and position; NOW, THEREFORE,

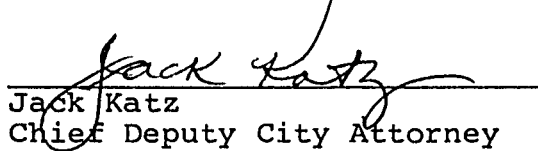
