That the bid of MODULAIRE INDUSTRIES is hereby accepted and the City Manager is hereby authorized to execute a contract for the LEASE OF TWO (2) EACH 12 FT. X 60 FT. OFFICE TRAILERS AND ONE (1) EACH 24 FT. X 60 FT. OFFICE TRAILER as may be required for a period of four (4) months beginning approximately March 1, 1984 through June 30, 1984, per prices on file in the Purchasing Department, for a total monthly lease charge of \$1,600.00 per month; terms net 20 days plus sales tax, plus set-up, tear-down, delivery and return charges totaling \$5,910.00; with an option to renew contract for two (2) additional one (1) year periods on an annual basis and for two (2) further one (1) year periods on a month-to-month basis, per prices on file in the Purchasing Department.
