filed in the office of the City Clerk of the City of San Diego, California, on FEB 27 1984 and bearing official Document No. U.O. 118081 be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

SAN YSIDRO COMMUNITY PARK - RECONSTRUCTION AND IMPROVEMENTS.

BE IT FURTHER RESOLVED, that the total expenditure of \$352,850.00 from CIP No. 29-427 SAN YSIDRO COMMUNITY PARK - BEAUTIFICATION; not to exceed \$241,000.00 from Capital Outlay Fund 30245; not to exceed \$52,000.00 from Park Service District Fund 11741; not to exceed \$4,273.00 from Park Service District Fund 11742; and not to exceed \$55,577.00 from Park Service District Fund 11743 is hereby authorized solely and exclusively for providing funds for said project and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
