APPROVING MAP OF VISTA DEL CIELO UNIT NO. 2

BE IT RESOLVED, by the Council of The City of San Diego as follows:


said Council hereby finds that certain map surveyed by Sydney S. Xinos, a registered civil engineer, entitled "VISTA DEL CIELO UNIT NO. 2, being a subdivision of those portions of Lots 27, 32, 35, 36, 43 through 50, inclusive, 157, 158 and 161 of Encima de San Diego Addition No. 1, according to Map thereof No. 1546, filed in the office of the County Recorder of San Diego County on March 18, 1913 and a portion of Lot 18 of Encanto, according to Map thereof No. 749, filed in the office of the County Recorder of San Diego County, State of California, on May 6, 1893, together with Margaritta Drive and a portion of Cielo Drive as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: portions of Woodman Street and Skyline Drive, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.
