BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which deed is on file in the office of the City Clerk as Document No. RR-260196-2, conveying to GERALD HANDLER, ET AL, a 1.876-acre portion of City Site 17-A, as part of the exchange of land for Beyer Neighborhood Park.

BE IT FURTHER RESOLVED, that the transfer of an 0.880-acre parcel of Water Utilities land, being a portion of City Site 17A, and as more particularly described in the legal description attached hereto and incorporated herein, to the Park and Recreation Department for Beyer Neighborhood Park is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$145,000.00 is hereby authorized as follows:

- a. From CIP 29-440.0, PSD Fund 11750, 16750 and 10743 \$35,800 to be paid to Gerald Handler, et al, which amount represents the difference in the values of the parcel conveyed and the parcel acquired, plus carrying costs; and \$10,600 for title, appraisal, closing costs and contingencies.
- b. From CIP 29-440.0, PSD 11750, for payment to Water Utilities Department Capital Outlay Fund 30246 \$81,000 for the value of the land to be sold to the developer; and \$17,600 as payment for the value of land to be conveyed to the Park and Recreation Department.
