A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REQUESTING THE CONSOLIDATION OF A SPECIAL MUNICIPAL ELECTION TO BE HELD IN THE CITY OF SAN DIEGO ON JUNE 5, 1984, WITH THE STATEWIDE PRIMARY ELECTION TO BE HELD ON THE SAME DATE.

WHEREAS, at a meeting of the City Council held on February 27, 1984, the Council indicated its intention to submit to the qualified voters of the City of San Diego one proposition relating to ratifying an ordinance authorizing the exchange, sale or lease to the United States of America of portions of Pueblo Lots 1276, 1304, 1305, 1306, 1318 and 1319 of the Pueblo Lands of the City of San Diego, at a special municipal election to be held in the City on June 5, 1984; and

WHEREAS, it is desirable that this special municipal election be consolidated with the statewide primary election to be held on the same date and that within the City of San Diego the election precincts, polling places, voting booths and election officials for the two elections be the same, and that the Board of Supervisors of the County of San Diego be authorized to canvass the returns of the special municipal election and that this special municipal election and the statewide primary election be held in all respects as if there were only one election; and

WHEREAS, this Council within the time required by law has or will adopt an ordinance calling for a special municipal election and consolidating it with the statewide primary

election; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. The Board of Supervisors of the County of San Diego is hereby requested to consolidate the special municipal election to be held in the City of San Diego on June 5, 1984 with the statewide primary election to be held on the same date, for the purpose of ratifying an ordinance.

2. The exact form of the proposition to be voted upon at this special municipal election and as it is to appear on the ballot is as follows:

PROPOSITION ORDINANCE NO. <u>0-16173</u> RATIFICATION OF (NEW SERIES). Shall Ordinance No. <u>0-16173</u> (New Series) entitled, "AN ORDINANCE AUTHORIZING THE EXCHANGE, SALE OR LEASE TO THE UNITED STATES OF AMERICA OF PORTIONS OF PUEBLO LOTS 1276, 1304, 1305, 1306, 1318 AND 1319 OF THE PUEBLO LANDS OF THE CITY OF SAN DIEGO," adopted by the Council of The City of San Diego be ratified? The proposition shall be designated on the ballot by a letter printed on the left margin of the square containing the description of each measure as provided in Section 10219 of the Elections Code of the State of California.

3. That the Board of Supervisors is hereby authorized to canvass the returns of this special municipal election and is requested to conduct the elections in all respects as if there were only one election using only one form of ballot.

4. That the Board of Supervisors of the County of San Diego is requested to issue to all officers of the County charged with duties pertaining to the statewide primary election appropriate instructions to take any and all steps necessary for the holding of a consolidated election.

5. That the City Clerk of The City of San Diego is hereby directed to file a certified copy of this resolution with the Board of Supervisors and Registrar of Voters of the County of San Diego.
