## RESOLUTION NUMBER R- 260198

Adopted on FFB 27 1984

WHEREAS, the City Council of The City of San Diego ("City") introduced Ordinance No. <u>J18180</u> (New Series) on <u>FFB 27 1984</u>, 1984, providing for the acquisition, construction and operation of the Southeastern Division Police Station on City-owned land through the issuance of Certificates of Participation ("Certificates") in an amount not to exceed \$3,200,000; and

WHEREAS, certain documents and acts require authorization in order to accomplish purposes of said Ordinance No. <u>0-16180</u> (New Series) when it becomes effective; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The forms of the hereafter listed documents are hereby approved and their execution on behalf of the City by the City Manager is hereby authorized:

a. The Site Lease between City and Imperial Municipal Services Group, Inc. ("Imperial") for purposes of the construction of the Southeastern Division Police Station, a form of said Site Lease is on file in the office of the City Clerk as Document No R260198, provided, however, that to the extent that the development of the Southeastern

Division Police Station results in excess land not needed for the Station itself, the City Manager be and is hereby directed to pursue the leasing of that acreage.

- b. The Assignment Agreement by and between City, Imperial and First Interstate Bank of California ("Trustee") whereby Imperial assigns to Trustee its rights under the Lease Purchase Agreement approved under Ordinance No. 0-16180 (New Series) and the aforesaid Site Lease, a form of said Assignment Agreement is on file in the office of the City Clerk as Document No. RP-260198-2
- c. The Agency Agreement between City and Imperial in which Imperial appoints City as its agent to carry out all phases of the construction of the Southeastern Division

  Police Station, a form of said Agency Agreement is on file in the office of the City Clerk as Document

  No. 7-260198-3
- d. The Official Statement relative to the issuance of the Certificates of Participation (Southeastern Division Police Station Project), a form of said Official Statement is on file in the office of the City Clerk as Document No. 1260198-4

Section 2. Sealed proposals for the purchase of said Certificates of City in the amount of \$3,200,000 are hereby authorized and the City Clerk is hereby authorized and directed to publish a notice inviting such sealed proposals by one insertion in The Daily Bond Buyer at least fifteen (15) days

prior to the date of opening the sealed proposals. The form of the notice in The Daily Bond Buyer is that which is on file in the office of the City Clerk as Document No. R-260198-5

Section 3. The City Clerk is hereby further authorized and directed to furnish to prospective bidders copies of the following:

- a. The detailed notice inviting proposals in the form of such notice on file in the office of the City Clerk as Document No  $\mathbb{R}^260198$
- b. The form on which proposals shall be accepted in that form on file in the office of the City Clerk as Document No. R-260198-7
- c. The Official Statement relating to the properties, operations and finances of said City, a form of which has hereinabove been approved.

However, failure, in whole or in part, to comply with this Section shall not in any manner affect the validity of the sale of said bonds.

Section 4. The City Manager and City Clerk are hereby also authorized, when acting on the advice of the City Attorney, to make such changes in the documents approved hereby as may be necessary or be required in order to accomplish the intent and purpose of this resolution and that of Ordinance No. <u>0-1618()</u>

(New Series) when the same becomes effective.

Section 5. The City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San

Diego, a letter agreement with IMPERIAL MUNICIPAL SERVICES
GROUP, INC. for services to be provided as Lessor for a sum not
to exceed \$10,000, payment of which shall be made solely from
the proceeds of the issuance of the Certificates of
Participation, for construction of the Southeastern Division
Police Station, a form of said letter agreement being on file in
the office of the City Clerk as Document No 260198.

empowered to execute, for and on behalf of The City of San Diego, an agreement for the printing of the Official Statement and the Certificates of Participation for a sum not to exceed \$20,000, payment of which shall be made solely from the proceeds of the Certificate issue, a form of said agreement being on file in the office of the City Clerk as Document No. R-260198—9

Section 7. The City Property Department is hereby authorized to obtain a title insurance policy as required in the Trust Indenture with respect to the issuance of the Southeastern Division Police Station Certificates of Participation and the expenditure of a sum not to exceed \$7,000 is further authorized, payment of which shall be made solely from the proceeds of the Certificate issue.
