WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Donna Baker	Police	\$ 1,650	Ms. Baker is a Senior Typist in the Police Department. She suggested that unnecessary paperwork be eliminated for the Juvenile Contacts Report. This is expected to save \$11,001 in the first year in costs for time.
Vincent DeLeva	General Services	\$ 1,595	Mr. DeLeva is an Electrician Supervisor in the Communications and Electrical Division. He suggested that the electrically illuminated one-way signs be replaced with reflective signs. This is expected to save \$10,640 in the first year in energy costs.
James Kline	Fire	\$ 625	Mr. Kline is a Fire Captain. One year ago he earned a partial award of \$150 for his suggestion to use a new method of repairing broken vehicle windows, instead of replacing them. One year's experience has shown a savings of \$2,575. This is the remainder of his award.
