Daniel B. Morse	Police	\$ 75	Mr. Morse is an Auto Messenger in the Police Department. He suggests that the Assignment Roster be revised to include mail stations. Although savings were difficult to identify, this was considered to be a significant operational improvement.
George Ikeda	General Services	\$ 50	Mr. Ikeda is a Carpenter in the Buildings Division. He suggested labels be placed over each lumber bin. This is considered to be a significant operational improvement.
Carol Jennings	Park and Recreation	\$ 50	Ms. Jennings was a Recreation Facility Caretaker when she suggested that a hazardous score booth be replaced. Although savings were difficult to calculate, this was considered to be a significant public safety improvement.
