

RESOLUTION NUMBER R- 260225

Adopted on MAR 5 1984

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of an excess right-of-way of a street or highway not required for street or highway purposes; and

WHEREAS, the adjacent property owners have requested the vacation of a portion of Linwood Street adjacent to Parcel 2 of Parcel Map 13116, and Lot 3 of Block 546 of Old San Diego Miscellaneous Map 40, to facilitate development of their property; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the portion of Linwood Street adjacent to Parcel 2 of Parcel Map 13116, and Lot 3 of Block 546 of Old San Diego Miscellaneous Map 40, as more particularly shown on Drawing No. 16089-B on file in the office of the City Clerk as Document No.

RR- 260225-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

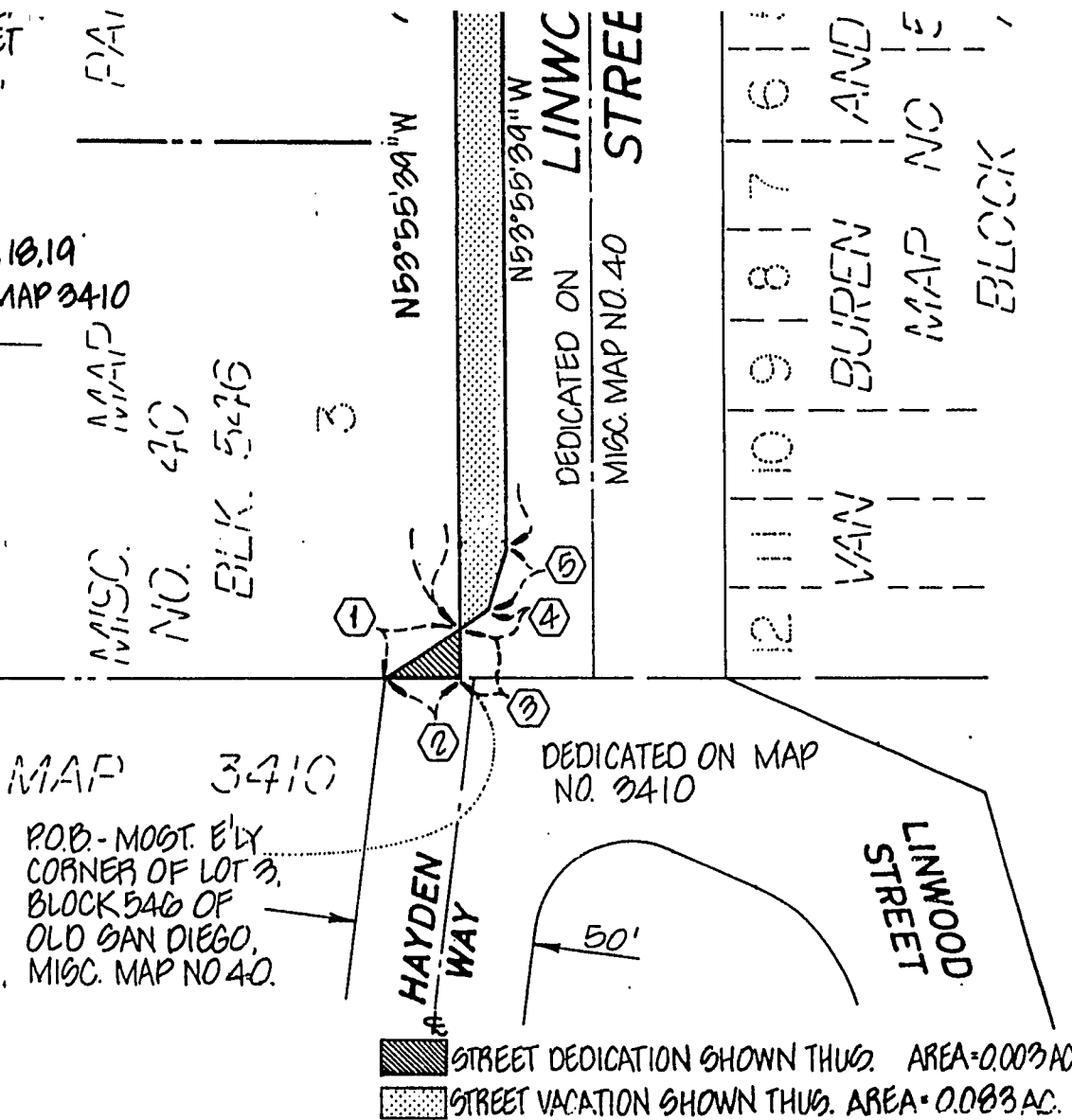
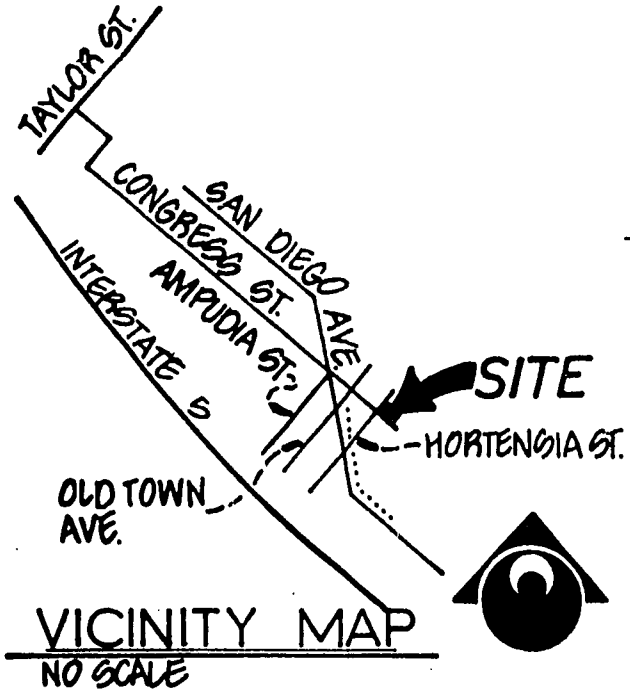
