RESOLUTION NUMBER R- 260233

Adopted on MAR 5 1984

WHEREAS, there are over 150,000 children illegally abducted each year and only 10% are located through current law enforcement procedures; and

WHEREAS, there exists a national nonprofit organization for the location of missing children called Child Find, Inc. which is building the only national registry in the United States available to separated children and searching parents; and

WHEREAS, in an effort to increase public awareness of this problem, twenty-eight states have, at the request of Child Find, Inc. and local Friends of Child Find Chapters, proclaimed May 25th as Missing Children's Day; and


WHEREAS, there exists within The City of San Diego a local organization called Friends of Child Find which to date has concentrated its efforts mainly in raising money for Child Find, Inc. through the sale of materials designed to prevent abductions, which effort is called OPERATION CHILD KEEP; and

WHEREAS, The City of San Diego wishes to publicly acknowledge the work being done to aid in locating and reuniting separated children and parents and the efforts being made to prevent abductions through OPERATION CHILD KEEP; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
that in recognition of the plight of all missing children and  
their searching parents, this Council does hereby proclaim May  
25, 1984 as "MISSING CHILDREN'S DAY" in The City of San Diego.
