1. That the bid of \$652,700.00 by CROWN CONTRACTING, INC., a corporation, for the POINT LOMA WASTEWATER TREATMENT FACILITIES ACCELERATED PROJECTS, INSTALLATION OF EXHAUST CATALYST SYSTEMS SEWER GRANT 530 PROJECT, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 147200.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$94,883.00 within Sewer Revenue Fund 41506 from the Unallocated Reserve (70697) to CIP No. 46-070 Sewer Grant Contract 530 (70292).
3. That the expenditure, not to exceed \$94,883.00 from CIP No. 46-070 Sewer Grant Contract 530 (70292) to supplement funds previously authorized by Resolution No. 259625, adopted on November 21, 1983, is hereby authorized solely and exclusively for providing funds for said project and related costs.
