

RESOLUTION NUMBER R- **260264**

Adopted on MAR 12 1984

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. Pursuant to the authority of San Diego Municipal Code Section 85.02, the City Council does hereby determine and establish the following streets as truck parking prohibited zones.
  - a. San Ysidro Boulevard between Camino de la Plaza and Via de San Ysidro;
  - b. Via de San Ysidro from San Ysidro Boulevard to southerly terminus;
  - c. Calle Primera from Via de San Ysidro to Willow Road;
  - d. Willow Road from Calle Primera to southerly terminus;
  - e. Front Street from Willow Road to New York Avenue;
  - f. Camino de la Plaza from Willow Road to San Ysidro Boulevard;
  - g. Via Nacional from Camino de la Plaza to southerly terminus;
  - h. Louisiana Avenue from Camino de la Plaza to southerly terminus;
  - i. Virginia Avenue from Camino de la Plaza to Encinita Street;
  - j. Sycamore Road from Calle Primera to southerly

terminus;

k. Camiones Way from Camino de la Plaza to southerly terminus; and

l. Willow Road from San Ysidro Boulevard to southerly terminus.


2. Pursuant to authority conferred by an in accordance with the provisions of Section 85.02 of the San Diego Municipal Code, a TRUCK PARKING TIME LIMIT OF THREE HOURS, except when loading or unloading be and the same is hereby established on the following streets in said City:

a. Clairemont Mesa Boulevard from I-805 to Pocahontas Avenue; and

b. Clairemont Drive.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said streets, and the regulations herein above imposed shall become effective upon the installation of such signs.
