WHEREAS, Berta J. Savage, Evan L. Otto et al. c/o Bill Graham, are the owners of certain real property and improvements located at 3768 National Avenue, San Diego, California, and more particularly described as follows:

Lots 41 and 42, Block 407 of Helphingstines Addition as per Map No. 450, filed September 21, 1887 in San Diego County Recorders Office;

and

WHEREAS, said residential premise has been found by the Building Inspection Director to be substandard and has been found to constitute a hazard to public safety, health and welfare by reason of inadequate maintenance, dilapidation and fire hazard; and

WHEREAS, the owners of the above-described property were notified by the Building Inspection Director of these findings; and

WHEREAS, on January 31, 1984, the Housing Advisory and Appeals Board at a public hearing approved said findings; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:
