

RESOLUTION NUMBER R- 260280

Adopted on MAR 12 1984

WHEREAS, the City Council adopted Resolution No. R-258792 effective July 1, 1983, establishing a minimum sewer capacity charge of six hundred and thirty-six dollars (\$636.00) per single family unit or equivalent in the City of San Diego; and

WHEREAS, it is necessary to establish a minimum sewer capacity surcharge of four hundred and fifty dollars (\$450.00) per single family unit or equivalent in addition to the citywide \$636.00 sewer capacity charge for the area to be served by the Otay Mesa Trunk Sewer System; and

WHEREAS, Section 64.0410 of the San Diego Municipal Code provides that minimum sewer capacity charges may be established by resolution of the City Council upon the giving of ten (10) days' notice of intention to establish, amend or increase said charges; and

WHEREAS, said notice has been given by posting the intention to establish said charges by the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to Section 64.0410 of the San Diego Municipal Code, the following minimum sewer capacity surcharge for services provided by Otay Mesa Trunk Sewer System is established:

A minimum sewer capacity surcharge of four hundred and fifty dollars (\$450.00) per single family unit or equivalent shall be paid. This surcharge shall be subject to six percent (6%) interest compounded annually from the effective date of this resolution, to and including that date the charge is paid.
