BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager and City Attorney are directed to prepare and negotiate a sole source contract for consultant services to lobby for the inclusion of funds in federal legislation (HR 3282) for a Joint United States-Mexico Wastewater Treatment Facility Project to include provisions that:

- (1) this consultant contract not exceed \$14,000;
- (2) the consultant to be hired work under the supervision of the Director of Intergovernmental Relations Department;
- (3) that the City Manager return to full Council as soon as possible for approval of this contract; and
- (4) that Council Policy 300-7 be waived.
