
Adopted on MAR 19 1984

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of ARLITA PURSER, executed in favor of The City of San Diego, bearing date of January 11, 1984, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 260297, granting to said City an easement for public street purposes in a portion of Lot 1 and Lots 7 through 12 inclusive of Block 5, a portion of Lot 12 of Block 6, together with portions of Heliotrope Street vacated, Golden Rod Street vacated and the alley vacated adjacent to Lots 1 and 12 of Block 5, all in the Sorrento Lands and Townsite, Maps 483 and 362, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named ROSELLE STREET.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
