WHEREAS, certain general utility and drainage easements were acquired at no cost for the development of the subdivision known as Bernardo Heights Phase V; and

WHEREAS, the existing easements are no longer compatible with the proposed development and the City has already acquired new easements which will serve the same purpose as those being abandoned; and

WHEREAS, the City has no present or prospective public use for said easements, and the City Manager has recommended that the City abandon its interests therein; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 260298-1, quitclaiming to BERNARDO HEIGHTS CORPORATE PARK, a general partnership, all the City's right, title and interest in the general utility and drainage easements, as more particularly described in the quitclaim deed.

deed and a certified copy of this resolution, attested by him
under seal, to be recorded in the office of the County Recorder.
