RESOLUTION NUMBER R- 260306

Adopted on MAR 19 1984

WHEREAS, The City of San Diego has worked cooperatively with the San Diego Association of Governments (SANDAG) to update growth forecasts for the San Diego Region; and

WHEREAS, this cooperative region-wide effort was initiated in order to obtain an updated set of growth forecasts to serve as a basis for local and regional planning; and

WHEREAS, these updated growth forecasts are consistent with The City of San Diego's adopted Progress Guide and General Plan and community plans; and

WHEREAS, local agreement on a set of growth forecasts will minimize questions about population growth often raised by federal and state agencies which fund capital facilities and, hence, save time and money for local jurisdictions seeking such funding; and

WHEREAS, these growth forecasts will be periodically updated to reflect actual changes in growth patterns and changes in local and regional plans and policies; and

WHEREAS, the acceptance of these growth forecasts will have no effect on the amount of state subventions received by The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Series 6 Regional Growth Forecast totals for the City, as set forth below, be and they are hereby accepted


and authorized for use in the preparation of local plans and studies:

BE IT FURTHER RESOLVED, that these growth forecast totals be and they are hereby authorized for use by SANDAG in undertaking the regional plans and studies described in its approved Overall Work Program.

BE IT FURTHER RESOLVED, that the City's representative to SANDAG is hereby authorized to support the adoption of the Series 6 Regional Growth Forecasts by the SANDAG Board of Directors as an element of the Regional Comprehensive Plan.
