BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Fourth Amendment to Agreement with LOWRY & ASSOCIATES, for a planning study for the Metropolitan Sewerage System from a cost not to exceed \$606,663 to a cost not to exceed \$731,245, under the terms and conditions set forth in the Fourth Amendment to Agreement on file in the office of the City Clerk as Document No. RR- **260316**.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$124,582 within the Sewer Revenue Fund (41506) from the Unallocated Reserve (70697) to the South Bay-Point Loma Sewage Treatment Plant (CIP 46-009, PE 70642), for the above purpose.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$124,582 from CIP 46-009, South Bay-Point Loma Sewage Treatment Plant, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
