

RESOLUTION NUMBER R-260325

Adopted on March 20, 1984

WHEREAS, a demonstration class competition among 32 competitors will be sponsored by Windsurfing International, a highly respected and well known board sailing manufacturer, during the 1984 Summer Olympics; and

WHEREAS, only one board sailing discipline, triangular racing, is a medal event presently recognized in the Olympics; and

WHEREAS, three other disciplines - slalom, freestyle and distance, require comparable skill and diligence; and

WHEREAS, a suitable demonstration of the slalom, freestyle and distance board sailing disciplines to the International Olympic Organizing Committee may result in their inclusion as medal events in the 1988 Olympic Games; and

WHEREAS, a site for the competition has not been selected; and

WHEREAS, San Diego has exceptional protected water areas and open coastline that would provide a superior setting for the demonstration competition; and

WHEREAS, the demonstration event will be held on August 10 and 11, a time of the year that is particularly idyllic in San Diego; and

WHEREAS, San Diegans have shown a vigorous enthusiasm for the sport and can be expected to support the demonstration competition in San Diego; and

WHEREAS, a board sailing event was held recently in Glorietta Bay, which provides knowledge of and competence in conducting this type of competition; and


WHEREAS, The City of San Diego will be required only to provide minor miscellaneous services as would be appropriate in any such similar public event; and

WHEREAS, The City of San Diego wishes to assist in promoting slalom, freestyle, and distance board sailing as Olympic events; and

WHEREAS, a considerable amount of prestige and economic benefit will inure to San Diego as the host city for the demonstration; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego be and it hereby does invite and encourage the International Olympic Organizing Committee to select San Diego as the site for the demonstration class competition of slalom, freestyle and distance board sailing in August 1984, during the Summer Olympic Games.
