BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of HAYES SECURITY NETWORK is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SECURITY GUARD SERVICE THROUGHOUT PENASQUITOS CANYON PRESERVE as may be required for a period of one (1) year beginning April 1, 1984 through March 31, 1985 at a cost of \$2,279.33 per month for a total cost of \$27,351.96; terms net 30 days, with an option to renew contract for two (2) additional one (1) year periods with a price escalation each year not to exceed 4% of monthly price bid.
