

RESOLUTION NUMBER R- **260336**

Adopted on MAR 26 1984

WHEREAS, Harry L. Summers, Inc., a California corporation, has requested an exchange of water easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easement to be acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of HARRY L. SUMMERS, INC., a California corporation, executed in favor of The City of San Diego, bearing date of February 8, 1984, conveying to said City a water easement in Lot 16 of Governor Drive Business Park Unit No. 4, Map 10671, as more particularly described in said deed, a copy of which is on file in the office of the City Clerk as Document No. RR-260336-1 is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-260336-2, quitclaiming to HARRY L. SUMMERS, INC., a California corporation, all of the City's right, title and

interest in the water easement in Lot 16 of Governor Drive
Business Park Unit No. 4, Map 10671, as more particularly
described in said deed.

3. That the City Clerk shall cause both deeds, and a
certified copy of this resolution, attested by him under seal,
to be recorded in the office of the County Recorder.
