

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a 50-year lease agreement with BOYS' CLUB OF SAN DIEGO, INC., for construction, operation and maintenance of a gymnasium adjoining the Encanto Boys' Club, and involving a portion of designated Encanto Neighborhood Park near 67th Street and Imperial Avenue, at a yearly rental of \$1,000 per year for the first five years of this agreement, and no rental thereafter, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 260340.
