APPROVING MAP OF CARMEL VALLEY NEIGHBORHOOD 5
UNIT NO. 2

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Tom R. McGannon, a registered civil engineer, entitled "CARMEL VALLEY NEIGHBORHOOD 5 UNIT NO. 2, being a subdivision of Parcel 21 and a portion of Parcel 20 of Parcel Map No. 12871, filed in the office of the County Recorder of San Diego County on August 26, 1983, in the City of San Diego, County of San Diego, State of California, together with a portion of Carmel Valley Road as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: San Leandro Way, San Gregorio Way, San Martine Way, San Augustine Way, Carmel Park Drive and a portion of Carmel Valley Road, and said streets and portion of street are hereby declared to be public streets and a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1, 2 and 3 of the Owner's


Certificate, as shown on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets and a portion of street are accepted on behalf of the public as heretofore stated, and that those easements listed in paragraphs 1, 2 and 3 of the Owner's Certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
