Robert J. Daneri	General Services	\$ 450	Mr. Daneri is an Equipment Repair Supervisor in the Equipment Division. He suggested that a less expensive paint heater seal be purchased. This is expected to save \$1,506.00 in equipment costs.
John F. Flynn	Police	\$ 420	Mr. Flynn is a Police Officer II in the Vice Unit. He suggested the elimination of xeroxing the arrest reports sent to the Vice Squad. This is expected to save \$1,397.54 in the first year in time and materials.
George R. Ikeda	General Services	\$ 238	Mr. Ikeda is a Carpenter in the Buildings Division. One year ago, he earned a partial award of \$50 for his suggestion to replace the metal ball casters used on chairs with hard rubber ones. One year's experience has shown a savings of \$960. This is the remainder of his award.
