Ted A. Myrus	General Services	\$ 70	Mr. Myrus is an Equipment Repair Supervisor in the Equipment Division. He suggested substituting one type of weight oil for the three weights previously stocked. This is considered to be a significant operational improvement.
Steven R. MacKaig	Fire	\$ 25	Mr. MacKaig is a Fire Fighter. He suggested that Fire Investigators be issued Nomex brush coats. This was considered to be a significant safety improvement.
Steven R. MacKaig	Fire	\$ 25	Mr. MacKaig is a Fire Fighter. He suggested that a back-up horn be installed on the 300 Maxivan. This was considered to be a significant safety improvement.
Bradley J. Cronk	Fire	\$ 25	Mr. Cronk is a Fire Captain. He suggested altering the method of administering the Fire Fighter class exams. This was considered to be a significant operational improvement.
