APPROVING MAP OF NORTH CREEK HOMES UNIT No. 1

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by W. R. Nothomb, a licensed land surveyor, entitled "NORTH CREEK HOMES UNIT No. 1, being a subdivision of Lot 1 through 29, inclusive, of Fortune Homes Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 9568 filed in the office of the County Recorder of San Diego County on February 22, 1980, together with Benfield Court as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Benfield Court, and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1 and 2 of the Owner's Certificate, as shown on this map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to


endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said street is accepted on behalf of the public as heretofore stated, and that those easements listed in paragraphs 1 and 2 of the Owner's Certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of Benfield Court approved by Council Resolution R-259300 on September 26, 1983, concurrently with the filing of the map.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
