APPROVING PARCEL MAP TM 82-0565

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain parcel map surveyed by Dennis L. Wahl, a registered civil engineer, identified as "PARCEL MAP TM 82-0565, being a subdivision of a portion of Lot 50 of The Highlands, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 284, filed in the office of the County Recorder of San Diego County, March 16, 1887," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the division of land shown thereon is hereby approved and accepted, and said Council hereby accepts on behalf of the public a portion of Dagget Street, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on said map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to

endorse upon said parcel map, as and for the act of the Council, that said Council has approved said parcel map and that said portion of a public street is accepted on behalf of the public as heretofore stated, and that the easement with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on this map within this parcel map, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said parcel map to the Engineering and Development Department of the City of San Diego for further handling.
