

RESOLUTION NUMBER R- 260410

Adopted on APR 03 1984

WHEREAS, it is The City of San Diego's intention to achieve certification of its Local Coastal Program ("LCP") by the California Coastal Commission; and

WHEREAS, an LCP includes land use plans, zoning and other related implementing ordinances, and zoning district maps; and

WHEREAS, there should be consistency between the implementing ordinances, zoning district maps and the coastal zone segment land use plans; and

WHEREAS, the Mission Beach Segment Land Use Plan is comprised of the Mission Beach Precise Plan and the Mission Beach Precise Plan LCP Addendum; and

WHEREAS, the Mission Beach Segment LCP is comprised of the Mission Beach Segment Land Use Plan and the Mission Beach Planned District Ordinance; and

WHEREAS, on January 19, 1984, the Planning Commission of The City of San Diego, held a public hearing, adopted, and recommended the approval of revisions to the Mission Beach Planned District Ordinance and the amendments to the Mission Beach LCP Addendum; and

WHEREAS, the revisions to the Mission Beach Planned District Ordinance address setbacks, parking requirements, video arcades, fence requirements, Ocean Front Walk encroachment permits and revisions necessary to implement the Mission Beach Segment Land Use Plan; and


WHEREAS, the amendments to the Mission Beach Precise Plan LCP Addendum are in response to actions taken by the California Coastal Commission; NOW, THEREFORE,

BE IT RESOLVED, that the Council hereby approves and adopts the proposed amendments to the Mission Beach Precise Plan LCP Addendum which are on file in the office of the City Clerk as Document No. RR- 260410.

BE IT FURTHER RESOLVED, that the Planning Department is authorized and directed to resubmit to the California Coastal Commission for their review and certification the Mission Beach Segment LCP which is comprised of the Mission Beach Segment Land Use Plan and the Mission Beach Planned District Ordinance.
