BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$97,500.00 from Convention and Performing Arts Center Fund 10320, CIP No. 34-046 CONVENTION AND PERFORMING ARTS CENTER - CARPETING is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
