RESOLUTION NUMBER R- 260424

Adopted on APR 09 1984

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the portion of street to be vacated consists of a portion of a street or highway that lies within property under one ownership and that does not continue through such ownership or end touching the property of another; and

WHEREAS, the abutting property owners have requested the vacation of Josephine Street between the northerly extension of the easterly line and the westerly extension of the southerly line of Lot "O," Block "C," of Silver Terrace, Map 695; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Josephine Street between the northerly extension of the easterly line and the westerly extension of the southerly line of Lot "O," Block "C," of Silver Terrace, Map 695, as more particularly shown on Drawing 16029-B on file in the office of the City Clerk as Document No. RR- 260424-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

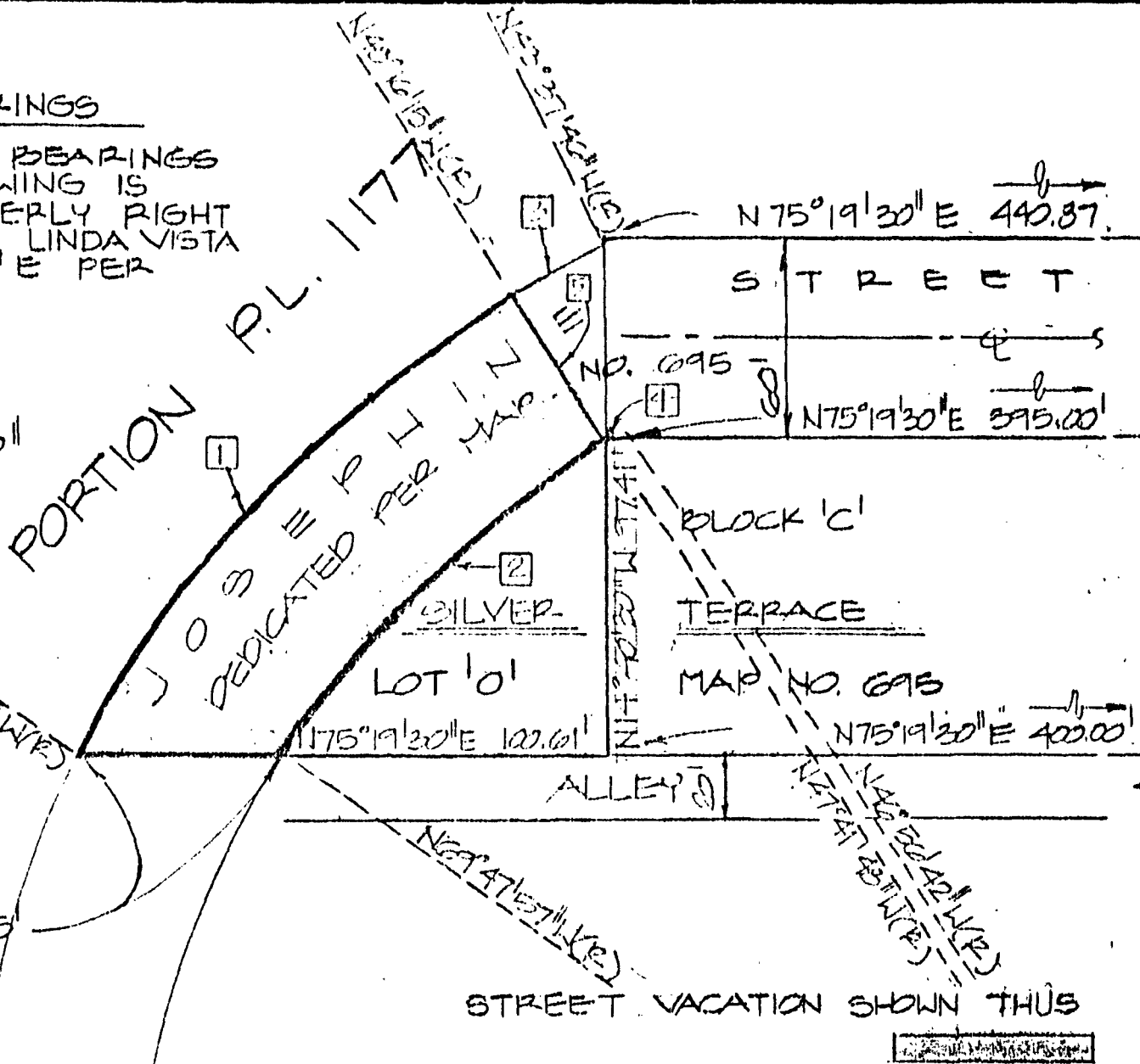

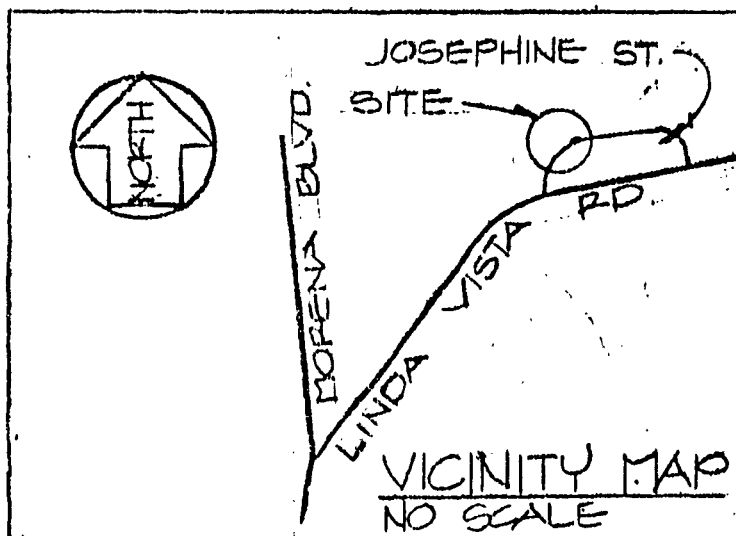
