BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and directed to take the appropriate actions necessary to accomplish a potential acquisition of the property,

and the expenditure not to exceed \$10,000 from Open Space Bond Fund 79102 for an appraisal of the subject property is hereby authorized.
