WHEREAS, the Planning Commission of The City of San Diego held a public hearing on March 1, 1984 to consider a proposed amendment to the UPTOWN COMMUNITY PLAN which would amend the land use designation on property described as Lots C and D, Block 226, Horton's Addition, DB13/522, located on the east side of Third Avenue between Fir Street and Elm Street, from medium density, residential development (15-44 dwelling units per acre) to office/residential; and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the amendment to the UPTOWN COMMUNITY PLAN; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the amendment to the UPTOWN COMMUNITY PLAN; and
