

RESOLUTION NUMBER R-260453


Adopted on April 10, 1984

WHEREAS, the Department of Intergovernmental Relations (IRD) provided a memorandum, dated April 10, 1984, to the Mayor and Council, recommending support of SANDAG's Ad Hoc Committee on Federal Hydroelectric Power in regard to HR 4275 (Udall); and

WHEREAS, SANDAG's Ad Hoc Committee's report and recommendation, dated March 22, 1984, was included as an attachment to IRD's memorandum and contained all the necessary background to the issue contained in IRD's memorandum relating to HR 4275; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby declares its support of the recommendations of SANDAG's Ad Hoc Committee on Federal Hydroelectric Power to support HR 4275 (UDALL) provisions which authorize additional capacity improvements to Hoover Dam; to seek an additional amendment for allocation of hydroelectric power to new applicants such as San Diego; and to deny the Utility Consumers Action Network's request for delaying the vote in the House of Representative.
