BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$272,920.00 from Sewer Revenue Fund 41506, CIP No. 46-080 METRO PRETREATMENT LABORATORY (70292) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
