APPROVING MAP OF AUTUMN RIDGE

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Norbert Rudolph Hamelehle, a licensed land surveyor, entitled "AUTUMN RIDGE, being a subdivision of Lot 9 and a portion of Lot 10 of Wadsworth's Olive Grove, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 482 filed in the office of the County Recorder of San Diego County, February 10, 1888," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: portions of 51st Street, Indianapolis Street and Euclid Avenue and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1, 2 and 3 of the Owner's Certificate, as shown on this map and subject to the conditions set forth thereon.


The Clerk of said City is hereby authorized and directed to
