APPROVING MAP OF EASTGATE PATIO HOMES

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Richard G. Grabhorn, a registered civil engineer, entitled "EASTGATE PATIO HOMES, being a subdivision of Stratton Acres, Unit No. 1, according to Map thereof No. 10246, filed in the office of the County Recorder of San Diego County on October 26, 1981, together with a portion of the north half of Lot 3 in Block 60 of Caruthers' Addition, according to Map thereof No. 27, filed in the office of the County Recorder of San Diego County on October 1, 1880, all being in the City of San Diego, County of San Diego, State of California, together with Stratton Avenue as closed and vacated to public use and together with portion of Logan Avenue as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for general utility purposes, as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the sewer access easements, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that the easements with the right of ingress and egress for the construction and maintenance of sewer facilities, as well as the easements for general utility purposes and the sewer access easements, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of Stratton Avenue, approved by Council Resolution R-260185 on February 27, 1984, concurrently with the filing of the map.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
